Meeting called to order at 6:40 pm

Chair Hanson read aloud the following notice:

Notice is hereby given that a special town meeting of the Town of Manitowish Waters, Vilas County, Wisconsin, will be held at the Town Hall, 5733 Airport Road on the 14th, day of November, 2023 immediately following the completion of the Public Hearing on the proposed 2024 Town Budget which begins at 6:00 p.m. for the following purposes:

1. To adopt a resolution by majority vote endorsing the Town Board's resolution to exceed the allowable levy limit under Wis. Stat. § 66.0602, by the requested amount.
2. To adopt the total 2023 Town tax levy to be collected in 2024 pursuant to Wis. Stat. § 60.10(1)(a).

Chair Hanson read aloud the Resolution by the Town Electors to Endorse the Town Board's Resolution to Exceed the Levy Limit, by **5.8%** over the allowable 2023 levy, which is a dollar increase of **\$78,267** over the allowable 2023 Town Tax Levy. A motion was made by Greg Holt and seconded by Jessie Mabie to endorse the resolution to exceed the allowable levy limit. A hand vote counted 12 "Ayes", 1 "nay" and 5 abstained from voting.

Chair Hanson read aloud the resolution by the Town Electors to Adopt the Total Town Tax Levy for 2023, (to be collected in 2024), in the amount of **\$1,436,275**. A motion was made by John Langowski and seconded by Jessie Mabie to adopt the total Town tax levy. A hand vote counted 13 "Ayes", 1 "nay", and 4 abstained from voting.

On a motion from Lynn Schroeder, seconded by Joan Farrell, the Special Meeting of Electors was adjourned at 6:56 pm.
